
**Sidney Rostan is appointed
Head of Insurance-Linked Securities (ILS)**

SCOR Investment Partners announces the promotion of Sidney Rostan as Head of Insurance-Linked Securities (“Head of ILS”), effective as of April 1st, 2019. Sidney Rostan replaces Vincent Prabis, who has chosen to give a new direction to his career.

Sidney Rostan, age 47, will be in charge of all of the Insurance-Linked Securities management business (including catastrophe bonds and collateralized reinsurance contracts), which amounted to more than USD 1.34 billion at the end of February 2019.
